

- We are a non-profit organization founded in December 2024 and incorporated in January 2025. Our membership has grown to over 20 part-time volunteers.


As a data-driven team, we are committed to the principle that **every eligible voter has the right to vote and have their vote counted accurately.**

WHAT WE DO

- **ANALYSIS** – Analyze election result data, visually represent that data, and assess the information for any concerning or unexpected patterns.
- **COMMUNICATION** – Convey complex technical findings about potential election manipulation in a more accessible manner to a broader, non-technical audience.
- **ADVOCACY** – Use appropriate mechanisms to urge for hand recounts of paper ballots and/or investigations into results that are statistically improbable or otherwise concerning.



HOAX BOMB THREATS ON ELECTION DAY


- The FBI confirmed that **multiple bomb threats** were made to polling places on Election Day. These threats appeared to originate primarily from Russian email domains.
- The number of bomb threats was initially under-reported. Post-election, **over 200 bomb threats** were documented impacting PA (34 counties), AZ (10 counties), GA (5 counties), MI (4 counties), and WI (2 counties).
- The intended purpose of these threats remains unclear, but could this include disruption of the paper ballot chain of custody?





2020-2024 SECURITY BREACHES AFFECTED TWO MAJOR BRANDS




**VOTING TECHNOLOGY
BRAND 1 PREVALENCE**




**VOTING TECHNOLOGY

'CLEAN SWEEP' OF THE SWING STATES

- In the 2024 U.S. Presidential Election, there were 7 'swing states'.
- The Republican candidate for President won 30 of 50 states, including all 7 swing states.
- All 7 swing states were won with a large enough margin of votes between the two main candidates that no state mandatory recount laws were triggered.
- The last time a candidate won all 7 swing states was 1984 in Ronald Reagan's landslide victory, in which he won 49 of 50 states.



88 of 88 FLIPPED COUNTIES WON BY ONE POLITICAL PARTY



- In the 2024 U.S. Presidential Election, the Republican candidate flipped **88 counties** while the Democratic candidate flipped **0 counties**.
 - This is despite the winning candidate receiving less than half (49.8%) of the popular vote.
- The last time a candidate flipped 0 counties in a presidential race was **almost 100 years ago** in 1932, when Franklin D. Roosevelt carried 42 of 48 states with 57.4% of the vote.
- Even in 1984, when Ronald Reagan won 49 of 50 states, around 30 counties flipped blue for Mondale.
